

# **MLA GUIDE**



A quick guide to citing in MLA style, based on the 8th edition of the MLA Handbook (2016).

#### Part 1. In-Text Citations

<u>Purpose of the in-text citation</u>: Directs the reader to the matching citation from the Works Cited page so that the reader can examine and look up that source.

Usually, all you need is the author's last name and the page number. If there is no author, use the title of the source followed by the page number (see last example below).

Format for corporate author:	(National Geographic Society 119)	National Geographic Society. <i>National Geographic Global Atlas</i> . 2014.
Format for unknown author (use the full title or abbreviated version of title):	(It Happened to Nancy 33)	It Happened to Nancy: A True Story from Her Diary. Edited by Beatrice Sparks, Avon Books, 2005.

## Part 2. Citations for Works Cited Page

For every in-text citation included in your paper, you must have a corresponding bibliographic citation in the Works Cited page.

Your Works Cited page should appear as the last page(s) of your essay or research paper.

When composing your Works Cited page, be sure that 1) it is **double-spaced**, 2) your citations are in **alphabetical order**, and 3) any citation that goes over two or more lines has a half-inch **hanging indent**.

The following are the formats and examples of common citations. Use these as guidelines to help you cite your own sources.

Format:	Author(s). Title of Book. Other Contributors, edition, Publisher, Year Published. Series.

	2. Citing an eBook from an Online Library Database	
Format:	Author(s) or Editor(s). <i>Title of Source</i> . Other contributors, version, vol. number, Publisher, Year Published. <i>Name of Database</i> , URL or DOI. Optional Date of access.

Format:	Author(s). "Title of Chapter or Article." Title of Anthology, edited by Editor(s) Name(s), edition, vol. number,
	Publisher, Year published, pages.

	4. Citing a Magazine or Newspaper Article from Paper Format
Format for magazine:	Author(s). "Title of Article." Name of Magazine, Issue Date, pages.

Format for newspaper:	Author(s). "Title of Article." Name of Newspaper, Issue Date, edition (if any), pages.
Examples:	DeParle, Jason. "Deal Close on Wiretap Law, a Top Democrat Tells CNN." <i>New York Times</i> , 3 Mar. 2008, late ed., p. A13. Martin, Hugo. "Resort Towns Seek a Lift from Airbnb Taxes." <i>Los Angeles Times</i> , 22 Feb. 2017, pp. C1+.

	5. Citing a Magazine or Newspaper Article from an Online Library Database
Format for magazine:	Author(s). "Title of Article." Name of Magazine, Issue Date, pages. Name of Online Database, URL of article. Optional Access Date.

Format for magazine:	Author(s). "Title of Article." Name of Magazine Website, Date published or last updated, Publisher if different name from the Title of Website, URL of article. Optional Access Date.
Example:	Greenblatt, Leah. "A Book of American Martyrs by Joyce Carol Oates: EW Review." Entertainment, 27 Jan. 2017,  Entertainment Weekly, ew.com/books/2017/01/27/a-book-of-american-martyrs-joyce-carol-oates-ew-review/.  Accessed 28 Feb. 2017.
Format for newspaper:	Author(s). "Title of Article." Name of Newspaper Website, Date published or last updated, Publisher if different name from the Title of Website, URL of article. Optional Access Date.
Examples:	Martin, Hugo. "More Skiers Turn to Short-Term Rentals – A Mixed Blessing for Resorts." <i>Los Angeles Times</i> , 22 Feb. 2017. LosAngelesTimes.com, www.latimes.com/business/la-fi-airbnb-ski-resorts-2017022-story.html.

	7. Citing a Journal Article from Paper Format	
Format:	Author(s). "Title of Article." Name of Journal, vol., no., Issue Date, pages.	
Example:	Fitzgerald, Elizabeth Moran, et al. "Anguish, Yearning, and Identity: Toward a Better Understanding of the Pregnant Hispanic Woman's Prenatal Care Experience." <i>Journal of Transcultural Nursing</i> , vol. 27, no. 5, Sept. 2017, pp. 464-470.	

	8. Citing a Journal Article from an Online Library Database or Website
Format:	Author(s). "Title of Article." Name of Journal, vol., no., Date published, pages. Name of Online Database, DOI or URL
	of article. Access Date suggested if using URL.
Example:	Dalonges, Debra A., and Jacquelyn L. Fried. "Creating Immediacy Using Verbal and Nonverbal Methods." <i>Journal of Dental</i>

Format:	Author(s). "Title of Web Page." Title of Website, Date the article was published or last updated, Publisher if different
	name from the Title of Website, URL. Optional Access Date.
Example:	Camacho, Jocelyn. "The Tattoo: A Mark of Subversion, Deviance, or Mainstream Self-Expression?" Scholar Commons, May
